RESOLUTION NO. 17 (SERIES 2026)

A RESOLUTION CREATING AND MAINTAINING A PROHIBITED STREET PARKING LIST

A. The Town of Gypsum, Colorado ("Town") is a home rule municipality organized and existing under Article XX of the Colorado Constitution and the Town's Home Rule Charter effective October 21, 1982.

B. The Town Municipal Code Section 10.01.030(7) authorizes the Town to designate streets or street segments where stopping, standing, or parking is prohibited.

C. Creating and maintaining a centralized Prohibited Street Parking List posted on the Town's website will promote transparency and facilitate consistent administration and enforcement.

D. Prohibiting parking on designated streets or segments is necessary to protect the public health, safety, and welfare by ensuring adequate emergency access, maintaining safe travel lanes and sight distances, improving pedestrian and bicycle safety, supporting transit operations and school-zone safety, and accommodating street sweeping, snow removal, and other maintenance activities.

E. The Town Council ("Council") hereby determines that establishing and maintaining the Prohibited Street Parking List is in the best interest of the community.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GYPSUM, STATE OF COLORADO THAT:

1. Prohibited Street Parking List. The Council hereby adopts the Prohibited Street Parking List set forth in Exhibit A, which is incorporated herein by reference.

2. Repeal and Ratification. All resolutions of the Council inconsistent with this Resolution are hereby repealed to the extent of such inconsistency and all actions of the officers, agents and employees of the Town which are in furtherance of or in conformance with the purposes and intent of this Resolution are hereby in all respects ratified, approved and confirmed.

3. Authority to Revise List. The Town Manager is authorized to modify the Prohibited Street Parking List as needed.

4. Severability. If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.

5. Effective Date. This Resolution shall take effect and be enforced immediately upon its approval by the Council.

This Resolution was introduced, read, and adopted upon a motion duly made, seconded, and passed this 23rd day of June 2026, by a vote of 7 in favor and 0 against.

EXHIBIT A

Prohibited Street Parking List

Streets in Town where on-street parking is prohibited; Parking passes are unavailable on the streets listed below:

- Highway 6
- Cooley Mesa Road
- Valley Road/Gypsum Creek Road
- Jules Drive
- Trail Gulch Road
- Oak Ridge Drive
- Oak Ridge Court
- Crestwood Drive
- Frontage Road (commonly called Gypsum Range Road)
- Scotch Creek Rd (Highway 6 to Broken Bridge)
- Bertroch Lane
- Eagle Street (Highway 6 to Gypsum Creek)
- All alleyways in the Town of Gypsum
- Eagle Court
- Vicksburg Lane
- Lundgren Boulevard
- Sunny Avenue (Between Green Way and Jules Drive)
- Springbuck (between Crockett Court and Spring Creek Road)
